**Old Business:**

**Fire/Ambulance Reports-** Andy Meyers is the new Chief of the Belmont Ambulance Service. The old tanker truck is up for auction with a minimum of \$7,000. The amount the truck is sold for will be split between the Townships that paid for the new tanker.

**Update on the northern Cottage Inn reconstruction LRIP proposal:** Cottage Inn needs a culvert and is in need of reconstruction, which requires additional gravel and a double seal coat. We did some ditching this fall. Any project with a price greater than \$65,000 needs engineering approval. The estimate for this proposal is \$73,903. The project has been approved at county level for \$35,000 LRIP funds but won't get state input until June/July of 2022.

**New Business:**

**Discussion and possible action on support of Belmont ambulance box remount on new chassis body.** After some discussion, Reggie made a motion to support a new ambulance and box with the Kendall Township share not to exceed \$40,000. A totally new ambulance is preferred since the expected life could be up to 40 years, warranty, and for having both ambulances available service. A remount would take the old ambulance out of service for possibly a couple of months until it is back in service. Bernie seconded it. Roll call was taken. Bernie – aye, Reggie – aye, Mark – aye.

**Public Comment:** None


Reggie made a motion to adjourn. Seconded by Bernie. All Ayes. Meeting adjourned at 8:26 pm.
