Meeting called to order by Chairman James Acherman at 6:00 p.m.

Minutes:

The minutes of February 8, 2021 meeting were reviewed. Andy Schilling motioned to approve the minutes and Dan Rielly seconded the motion. Majority were in favor. No one opposed.

Meetings Attended and Other Correspondence

No ambulance meeting was held. The hospital hired a medical director. Assessor was here a few days ago working on assessments. The trailer home behind the former bowling alley has been burnt down. Dan Rielly reported on the Fire Department meeting. Annual meeting was Monday night and 12 to 15 people attended. There will be training on house at Holy Rosary church. Trucks are good. Getting calls from people to do grass fires. Looking at prices for new pump truck.

Old Business

- A. GFL Recycling - Dump site has been very busy. Getting a lot of cardboard. GFL rates and invoices are up to date.
- B. Patrolman/Recycle Contract - Some discussion on whether or not to have a full time position. The person must have a CDL. Benefits were recommended such as vacation time, sick time, but no health insurance or retirement. Also was mentioned to pay \$20 per hour and remove one or two holidays. It was decided to set up an interview some evening to meet with a couple of interested parties. This will be closed session and will be posted at three locations.
- C. Unpaid Personal Property Taxes - There are a few people that have not paid their personal property taxes. Some of these people owe for more than one year. The Treasurer is sending them a letter to pay these taxes by the end of the month. If not paid another letter will be sent saying they may be taken to small claims court if not paid within 30 days.

New Business

B. Annual Meeting - April 20, 2021 - Andy Schilling motioned to have our regular monthly meeting the same day as the annual meeting with the annual meeting starting at 6:30 p.m. and the regular monthly meeting to follow. Dan Rielly seconded the motion. Majority were in favor. No one opposed.

Treasurer's Report

The treasurer's report was reviewed as well as the invoices received this past month. Dan Rielly motioned to approve and pay these invoices. Andy Schilling seconded the motion. Majority were in favor. No one opposed. Motion carried. See attached spread sheet.

Other Business:

Joe Reichling asked if he could update the fence around the Willow Springs Cemetery on Ferndale Road. He would do this at his own expense. The board approved putting up a new fence but the gate must remain there for use of lawn mowing, etc.
