Lafayette County Board of Supervisors Minutes Tuesday, April 16, 2019 • 7:30 p.m. Lafayette County Board Room

The Lafayette County Board of Supervisors' meeting was brought to order at 7:30 p.m., on Tuesday, April 16, 2019 by County Board Chairman, Mr. Jack Sauer. A prayer was led by Mr. Bob Boyle. The Pledge of Allegiance was led by Chairman Sauer. Roll call was taken by Lafayette County Clerk, Carla Jacobson, beginning with Ms. Korn. There were Fifteen (15) members present with one member absent. Chairman Sauer declared a quorum. Pedley – District 15; and Rita Buchholz – District 16. Andy Schilling - District 5, had an excused absence.

Chairman Sauer asked the County Clerk, Carla Jacobson, if the meeting notice was properly posted. Ms. Jacobson said the meeting notice was posted in the Courthouse, at the Darlington Municipal Building, at Memorial Hospital of Lafayette County, on the Lafayette County Website, and was sent to the press.

Chairman Sauer asked the board for approval of the agenda. Motion by Heimann, second by Spensley, to approve the agenda as presented. Voice vote. Motion carried.

Chairman Sauer asked the board's wishes regarding the minutes from the March 19, 2019 Lafayette County Board of Supervisors' meeting. Motion by Ludlum, second by Ruesga, for approval of the minutes as presented. Voice vote. Motion carried.

ADOPTION OF REVISED 2016 – 2026 LAFAYETTE COUNTY FARMLAND PRESERVATION PLAN

Whereas, the County Board of Lafayette County, Wisconsin has adopted Resolution 40-07 the "Lafayette County Comprehensive Plan" pursuant to ss.66.101 (4)(c) of the Wisconsin Statutes;

Whereas, Lafayette County adopted a Farmland Preservation Plan in 2016 that was certified by the Wisconsin Department of Agriculture, Trade and Consumer Protection (DATCP) as making qualified land eligible for farmland preservation tax credits;

Whereas, The Farmland Preservation Program empowering statue, Chapter 91 WI. Stats., was revised by the 2009-2011 Wisconsin Administrative Rules promulgated in 2010 directing the comprehensive revision of all existing county farmland preservation plans;

Whereas, Chapter 91.10(2) WI. Stats. Now requires consistency between the Farmland Preservation Plan and the county's Comprehensive Plan, which DATCP has deemed accomplished by incorporating the Farmland Preservation Plan and Farmland Preservation Ordinance into the Comprehensive Plan;

Whereas, the Lafayette County Conservation and Zoning Department and the Lafayette County Planning and Zoning Committee contracted Southwestern Wisconsin Regional Planning Commission to prepare and submit to DATCP an update to the existing Lafayette county comprehensive Plan and the Farmland Preservation Plan;

Whereas, the final draft of the revised Farmland Preservation Plan and Farmland Preservation Ordinance have been reviewed and certified by DATCP with the condition that it be approved by the Lafayette County Board and incorporated into the Lafayette County Comprehensive Plan:

Whereas, the final draft of the revised Farmland Preservation Plan and Farmland Preservation Ordinance have been reviewed and certified by DATCP with the condition that it also be approved by the Lafayette County Board and incorporated into the Lafayette County Comprehensive Plan to include the maps of the Blanchard Township;

Whereas, a public hearing was held before the Lafayette County Planning & Zoning Committee on April 4, 2019 as required by ss. 66.1001(4) Wisconsin Statute after which action was taken by the Committee to recommend approving the revised Farmland Preservation Plan for incorporation into the Lafayette County Comprehensive Plan as Appendix A1.

Passage of this Ordinance would make it unlawful to operate an ATV, UTV or OHM on any public trail or approved route in Lafayette County without an insurance liability policy covering the unit being operated and the owner or operator has in his or her possession a certificate or proof of insurance covering such unit which shall be displayed upon demand from any law enforcement personnel. Any person who violates any provision of this Ordinance shall, upon conviction, be subject to a forfeiture not to exceed \$200.00. Chairman Sauer said that this was a first reading of this Ordinance and that the second reading to act on this Ordinance will be held at the next County Board meeting.

- 2. Employees must have approval of their supervisor to use personal time. Unused personal days cannot be carried into the following year and will not be paid out as cash in lieu of taking time off; unused days/hours are forfeited.

- 4. Personal days earned on or after November 1, may be used within the first 60 days of the next year.

In order to provide coordinated leadership necessary to establish and foster innovation, effective corrections programs for adult and juvenile offenders and to effectively qualify for state and federal grants to fund such programs, a formal Lafayette County Criminal Justice Coordinating Council should be established. The principal mission would be to enhance public safety in Lafayette County through community collaboration by ensuring offender accountability, providing effective rehabilitation programs, and supporting the rights and needs of victims. The membership of the CCJC shall consist of the Circuit Court Judge for Lafayette County, Corporation Counsel for Lafayette County, a Lafayette County Board Supervisor, Lafayette County Sheriff, Chief of Police of Lafayette County Seat, Lafayette County District Attorney, Lafayette County Victim Witness Coordinator, Lafayette County State Public Defender, a Lafayette County Department of Corrections Agent, Lafayette County Human Services Director, a Citizen of Lafayette County, Lafayette County Child Support Administrator and others from the community as needed and desired. The CCJC would have the authority to appoint committees, subcommittees, and ad hoc committees and would have authority as granted by its by-laws. The Executive, Rules and Legislative committee recommends establishing the Lafayette County Criminal Justice Coordinating Council with the mission and membership described above. Provided such recording is used solely for the aforementioned purpose, and provided it is maintained solely by the Clerk between the time such recording is made and the official Minutes are ratified by the County Board or Committee to which such Minutes pertain, such recording constitutes a note under Wisconsin's Public Records Law and, therefore, does not constitute an official County record.

Because such recording does not constitute an official County record under the Public Records Law, the Clerk is authorized to and should delete, discard of, or otherwise destroy such recording upon the County Board's or applicable Committee's ratification of the official Minutes that were drafted by the Clerk in relation to such recording. Likewise, because such recording does not constitute an official County record under the Public Records Law, such recording is not subject to disclosure under the Public Records Law.

Any persons, including elected officials, may record any public meeting and maintain that recording for their own personal use.

WHEREAS, legalizing marijuana for adults normalizes the use of this brain-altering substance, leading to greater exposure, via ambient smoke, to children from infants through teenagers, and access to the substance by teenagers for experimentation, casual use and chronic use; and

WHEREAS, developing brains, especially those of babies in utero, children and teenagers, are especially susceptible to the harmful effects of marijuana, including a reduction in attention, memory and learning function, leading to behavior problems; and

WHEREAS, occasional use of marijuana caused altered senses and skewed senses of time, changes in mood, impaired body movement, impaired memory and difficulty with thinking and problem solving; and

WHEREAS, the Center for Disease Control and Prevention reports evidence from multiple studies linking heavy marijuana use to memory damage, learning and attention deficits, and an increased risk of anxiety, depression and schizophrenia, further straining schools and mental health systems; and

WHEREAS, marijuana negatively affects skills needed for safe driving and is the drug, after alcohol, that is most often found in the blood of drivers involved in crashes; and

WHEREAS, national experience with other legal adult substances, such as alcohol, tobacco and vaping has led to youth access, experimentation, some chronic use and infiltration into America's high schools, causing multiple, costly consequences related to discipline and mental health; and

WHEREAS, marijuana has been identified as a gateway drug and its use by teenagers does not promote a safe, efficient school learning environment for all students and further challenges teachers and counselors

to deal with the side-effects on a student's mood, behavior, motivation and memory: and

WHEREAS, adolescent and young adult marijuana use is negatively correlated with high school and post-secondary educational attainment;

WHEREAS, marijuana substantially increases the risk of impairment for those working in manufacturing, construction, agriculture and other business sectors, as evidenced by data showing employees who test positive for marijuana use had 55% more industrial accidents, 85% more injuries and 75% greater absenteeism compared to those who tested negative;

WHEREAS, retail business establishments identify concerns with verbal and physical altercations involving substance users that can negatively impact business and revenue; and

WHEREAS, states with legalized marijuana have experienced an increase in unintended consequences including, but not limited to, increases in motor vehicle crash rates, increases in marijuana addiction among youth, environmental issues, accidental childhood poisonings from ingesting edibles and increase in criminal behavior including organized crime.

NOW, THEREFORE, BE IT RESOLVED that the Lafayette County Board of Supervisors does hereby oppose the legalization of marijuana in the State of Wisconsin; and

BE IT FURTHER RESOLVED that the Lafayette County Board of Supervisors urges the State of Wisconsin to closely review the statistics and other data available surrounding marijuana use so that Wisconsin can remain a safe and healthy State for residents and visitors to enjoy recreational activities, support families and drug-free homes, attract entrepreneurs, and provide for the future of our State; and
