Applications must first be reviewed by the Town Planning Commission, which shall make a recommendation to the Town Board on granting or denying an application for a kennel license within thirty (30) days of receipt of the application. In reviewing the application to keep more than three (3) dogs which are six (6) months old or older, the Planning Commission and the Town Board shall consider at least the following information:
