Meeting was called to order by Chairman, Mark Rehmstedt at 7:30 pm.

Patrolman's Update: The first mowing is done. The patrolmen have been doing some ditching. The Township is going to have the County do some of the ditching with their backhoe since it is so hard on the Town's equipment's tires. The men have also replaced some missing road signs.

Old Business:

Fire/Ambulance Reports- The meeting was rescheduled to September 15th, 2021, due to the passing of Fire Board Secretary, Steve Kenyon.

Discussion on road projects for the year- Scott's did an extra \$3500 in patching. Kendall Township is going to postpone seal coating Truman Road since it is getting so late in the season. Carl from Scott's said they would be here in June of 2022. The County has done 2.5 miles of seal coating, and some patching. There was also some discussing on which roads should be worked on next.

Discussion and possible action on patrolman position: The radio ads on 99.3 & 96.9 did not generate any calls for the patrolmen position. Mark has posted the job on Indeed.

New Business:

Discussion and possible action on borrowing for road work funds: The road repair loan from last year of \$45,000 will be paid next month. The debt service remaining for next year for the two fire trucks combined is \$27,600. If the Town borrows \$34,000 for road work for next year, the levy shouldn't be affected compared to the last few years. After some discussion, Bernie made a motion to borrow \$34,000 for one year for road maintenance. Reggie seconded it. Roll call: Bernie – aye, Reggie – aye, Mark – aye. Motion carries.

Public Comment: None


Bernie made a motion to adjourn. Seconded by Mark. All Ayes. Meeting adjourned at 8:41 pm.


