1. Call to Order at 8:02 PM by Chairman Bonin; Pledge of Allegiance.

- 2. Verify Public Notice, Approval of Agenda and Approval of May 12, 2021 Meeting Minutes
  - a. The Clerk verified proper posting was done per Wi s. 60.12.
  - b. Motion by Buchs, second by Clayton to approve the agenda moving 8.c to 3. Motion passed 3-0.
  - c. Motion by Buchs to approve the 5/12/2021 Meeting Minutes with changes suggested by Clerk McGuire, second by Clayton. Motion passed 3-0.

# 3. Presentations & Public Comment Forum

Public Comment Forum: Members of the public are welcome to address the Town Board. Pursuant to WI Statutes 19.83(2) and 19.84(2), the public may present matters; however, they cannot be discussed or acted upon until specific notice of the subject matter of the proposed action can be given.

- a. Joan Kincaid from Lake Joy made a presentation to request Retail Class A Fermented Malt License. Joan presented her reasons: all campers over 21, campers have been requesting it for years, all other campgrounds in area already have license to sell liquor. Retail license holder for over 20 years with State. Lake Joy would like to have a small selection of packaged beers in convenience store for campers to be consumed at their campers, not in store. Beer sales strictly for registered campers. Chairman Bonin advised visitors that Township has no ordinance for such liquor license currently, and added that Town Board would consider the request in the future.
- 4. <u>Financial Position Report</u> (Treasurer's Report) Motion by Buchs to approve Treasurer's Report; Clayton second. Motion passed 3-0.

- a. Approve Payment of Bills Motion by Clayton to approve payment of bills; Buchs second. Motion passed 3-0. Signed by board members.
- b. Review Staff Hours Report and Sign Staff hours presented and signed by board members. Motion by Buchs to approve staff hours; Clayton second. Motion passed 3-0.
- c. Form SL-330: Coronavirus Local Recovery Funds Request to request American Rescue Plan Act Local Fiscal Recovery Funds (LFRF) deadline June 18, 2021. Motion by Clayton to fill out Form SL-330; Buchs second adding to set up a separate account to receive ARPA monies. Motion passed 3-0.
- d. Voting Equipment Training Update Clerk and a poll worker attended June 8 training in Lafayette County Multipurpose Building. Current voting equipment will not be serviced after Jan 1, 2023. County advising municipalities to order new machine this year for better pricing, and to be able to use new machine in 2022 spring elections. Two machines available: 1. ICX Touch Screen Tabulator for \$3,299 plus training and shipping fee, and 2. ICE Tabulator for app. \$6,500 plus training and shipping. Buchs makes motion to request contract and additional information about ICX Touch Screen Tabulator; Clayton second. Motion passed 3:0.
- e. Absence in July Clerk will be absent from July meetings. Treasurer will substitute clerk.

Platteville Fire / EMS (Ryan Simmons) The School District of Platteville and the City of Platteville are currently in the final stages of a land sale/transfer agreement in which the School District will sell the City the unused OE Gray School building and property for \$1. Replacement schedule for the fire department vehicles will be available in the upcoming months.
- c. Belmont Fire / EMS (Supervisor Buchs) Buchs gave updated report: new radios, 2 new EMTs passed their test in June.
