**Monthly Board Meeting**  
**July 11, 2022**

Meeting was called to order by Chairman, Mark Rehmstedt at 8:15 pm.

Roll call was taken. Board members present Mark Rehmstedt and Bernie Fogel. Reggie Kamps arrived a few minutes later.

Meeting agenda was posted at the Town Dumpsite, the Town Hall, and the Corner of County Road G & County Road O.

**Patrolman's Update:** The patrolmen have spread chips and lime at least nine times on Truman Road. Scott is supposed to be paying the cost of the chips and lime. Elk Grove and Belmont also had issues with work Scott has done. Town of Kendall (TOK) will be invoicing Scott's for the extra supplies and labor spent on Truman Road. The warranty on the road ends in September. TOK is going to request that Eileen write a letter to Scott's. The blue truck does not currently have air conditioning but we haven't gotten it fixed because we need it for Truman Road. Brian has finished the first pass of mowing.

Approval of the June 13<sup>th</sup> Monthly Meeting Minutes – Reggie made a motion to approve the June 13<sup>th</sup> Monthly Meeting minutes, Bernie seconded it. Roll call was taken. Bernie – aye, Reggie – aye, Mark – aye. Motion carries.

**Old Business:**

**Fire/Ambulance Reports-** There has been no Fire District meeting since the last Kendall Township meeting.

**Discussion and possible action on the fence viewing determination between Vingers and McWilliams:** A decision was forwarded to the Vingers and to Tom McWilliams regarding repairs and a timeline. Mark made a motion to accept the repair notice. Reggie seconded it. A roll call was taken. Mark – aye, Reggie – aye. Motion carries.

**Discussion and possible action on County Zoning requests:** After some discussion, Mark made a motion to request County zoning permit requests for new homes, new or changing driveways, and building not meeting property set back requirements. Reggie seconded it. Roll call was taken. Bernie – aye, Reggie – aye, Mark – aye. Motion carries.

**Discussion and possible action on heavy traffic on Woods Branch Road:** Mark has contacted the milk hauler who drives on Woods Branch Road. Mark asked that the pickup be made when the truck is lighter. Initially the driver complied, but now he is not. The road is getting torn up. After some discussion, Reggie made a motion to contact Eileen to request that she write a letter to the driver. Bernie seconded it. Roll call was taken. Bernie – aye, Reggie – aye, Mark – aye. Motion carries.

**Discussion and possible action on patrolman position:** Reggie contacted Kory at UW-Platteville. He will talk to students when they are back for school regarding the position.

**Discussion on road maintenance projects for this year:** Airport needs to be ditched. Also will do work on patching potholes.

**Discussion on the American Rescue Plan Act (ARPA):** Kendall Township received the second payment. The bulk of the money will be used for the Belmont Ambulance.

**New Business:**

**Discussion and possible action on contracting LP for the fall:** After some discussion, Reggie made a motion to book 1500 gallons at \$1.79/gallon. Bernie seconded it. All ayes, motion carries.
