The bills for the month were presented for payment. After some discussion, a motion was made by Reggie Kamps to approve the bills to be paid. Bernice Flogel seconded. A roll call vote was taken. Bernie – aye, Mark – aye, Reggie – aye. Motion carries.

Correspondence: The Township has received letters regarding the fencing issue between Jason & Nikki Vinger and the Thomas McWilliams Trust. This will be further discussed later in the meeting.

The July monthly meeting will be held on July 11th, 2022 at 8:00 pm.

Patrolman's Update: The patrolmen have done some ditching on Derry Road and Jenson Lane. Bill and Scott hauled the dirt away. A culvert caved in on Truman Road and was replaced. It was rusted out on about 2/3 of the length on the bottom. Did three new culverts on Jenson Lane.

Old Business:

Fire/Ambulance Reports- The delivery of the new ambulance has been delayed because of supply issues. The Ambulance Service had 15 calls in May. Six hundred twenty-one people attended the pancake breakfast. Fire/Ambulance spent \$4000 on tools and fittings.

Discussion on road maintenance projects for this year: The Cottage Inn Road project is in the system looking for approval. A decision on this project should be made in the next month or so. There was some discussion on repairing the apron in front of the Town Hall.

Discussion on the American Rescue Plan Act: The second half of the payment should be received next month. The Township will be using most of the funds to pay for it's share of the new Belmont Ambulance.

New Business:

Discussion and possible action on fence viewing between Vingers & McWilliams: After some discussion, based on the Vinger's request, a fence viewing time was set for 8:00 am on the 29th of June, 2022. Mark Rehmstedt and Reggie Kamps were nominated to be the viewers.

Discussion and possible action on County Zoning requests: After some discussion, a decision was made to table the topic at this time.

Discussion and possible action on heavy traffic on Woods Branch Road: The milk truck that stops at Lapps has been hard on Woods Branch Road this spring. A request was made for the truck driver to come in lighter three times without any results. In the past 2-3 years, the request was complied with, but the request has been ignored this year. The road has a weight limit on it for March 1st to May 1st. It was suggested the Town's Attorney be contacted, which the Chairman will do.

Discussion and possible action on part-time patrolman position: After some discussion, it was decided that Reggie would contact UW-Platteville to see if any professors knew of any candidates.

Public Comment: An elector asked for the checkbook balance.

Bernie made a motion to adjourn. Seconded by Reggie. All Ayes. Meeting adjourned at 8:41 pm.
