The 2024 Budget will be presented November 13th, 2023. The Proposed Budget meeting will be at 6:30 pm. It will be followed immediately by the Electors' Meeting, then the Board Budget meeting, and then the November monthly meeting.

Patrolman's Update: The patrolmen have done some patching and put some gravel down. The tranny lines were fixed, but they still leak. Bill, Brian and Mark trimmed some trees on Brunton Lane. Bill rented the Township his skid loader and grapple, which made the job easier. The hydraulics on the grader need to be looked at more to determine if repairs are needed.

Old Business:

Fire/Ambulance Reports- The 2024 Belmont Fire District budget was approved. The 2024 dues will be exactly the same as 2023. The EMS department went on 12 calls last month, which is more than normal. The new brush truck should be delivered August 2024.

New Business:

Discussion & possible action on the Garbage and Recycling Contract: The Township has been working with Faherty Incorporated. The cost has gone up 2%, or a little over \$9 a month for next year. The contract is for 5 years, and the price is guaranteed to not increase more that 3% per year. Reggie made a motion to approve signing a new 5 year contract with Faherty Incorporated for garbage and recycling. Bernie seconded it. A roll call vote was taken. Bernie – aye, Mark – aye, Reggie – aye. Motion carries.

Bernie made a motion to adjourn. Seconded by Reggie. All Ayes. Meeting adjourned at 8:46 pm.
