

- Partnership with Faith in Birth Midwifery to offer Lab Services for the local Amish Communities
- ✓ Water Testing Lab for Bacteria (total coliform), Nitrates, Nitrite, Lead and Arsenic
- ✓ Partnership with First Breath for smoking prevention

Our Environmental Health programs provide community outreach and education on environmental health issues. The following areas are handled within our Department:

- Air & Water Quality-Water & Radon Test Kits are available at our office.
- **Human Health Hazards**-Investigations may take place to make sure that our residents are living in safe conditions.
- **Mosquito & Arboviral Control**-Education on prevention and treatment are available.
- Asbestos & Mold-Educational materials are available. Any type of inspection is based on the environmentalists, need to basis.
- Lead Hazards-Educational materials are available Any type of inspection is based on the environmentalists, need to basis.
- **Public Health Nuisance**-Investigates and addresses public health nuisances, and enforce the public health nuisance ordinance.
- Flood Safety-Educational materials are available.
- Radon Test Kits-Free Radon Test Kits are provided to Lafayette County Residents.

Childhood Lead Testing

Our Public Health Nurses conduct lead testing follow-up including phone calls, home visits, consultation with the primary health provider and a home risk assessment if lead levels are 5 or greater. A blood lead level of 5 or greater is considered to be lead poisoning.

TNC (Transient non-community) Water Systems

Our Health Department ensures safe drinking water at all establishments in the County who provide their own private well water to the public. This is done through a process of regular testing, education and guidance for these establishments. The Health Department does testing on establishments that serve a minimum of 25 people for at least 60 days/year, but not the same 25 people over 6 months. The most common establishments that we serve through this program are campgrounds, restaurants, taverns, churches, parks and golf courses.

Immunizations for Children & Adults

Our Department offers vaccines for adults and children through the federal VFC and VFA programs. In addition to these programs, our Department offered flu vaccines for children with a total of 990 this year. In 2019 we increased our immunization Benchmark rates among children in the County by 7%:

- 2019 Benchmark Report for Children 24 months & under: Total Clients: 203
- Clients that met all benchmark criteria: 121 (60%)
- Late up-to-date clients: 136 (67%)
- Amish Clients: 36 (18%)

<u>versus</u>

- 2018 Benchmark Report for Children 24 months & under: Total Clients: 207
- Clients that met all benchmark criteria: 109 (53%)
- Late up-to-date clients: 125 (60%)
- Amish Clients: 35 (17%)

Additionally, we increased our School Flu Immunization Clinics by 3.75%

2018= 938 students 2019= 973 students

Overall Immunizations decreased this year for two reasons:

- 1. We did not have private flu this year
- 2. Local providers are carrying and providing immunizations to insured clients

Water Quality Program & Bacteria Lab

Lafayette County Health Department recommends that all wells used for drinking water be tested annually for safety. In 2019, the Department became DATCP Certified Water Testing Laboratory for Bacteria (total coliform). In addition to the lab, Our Department offers private well water testing kits along with educational materials and techniques that allows residents of the County to properly test and monitor their own well water.

Loan Closet

Our Department offers a loaner program for gently used walkers and wheelchairs. This program is funded through donations from residents and healthcare agencies in the County. We ask for a small donation for any equipment that is borrowed and we are always accepting gently used walkers and wheelchairs for this program.

Total Loan Closet items loaned to County Residents in 2019: 96

Sharps Program

Lafayette County Health Department offers a free sharps container and disposal program. This program offers a safe way to dispose of sharps containers. Residents can also pick up empty sharps containers to properly dispose of their sharps at home.

School Nursing Services

Lafayette County Health Department provides school nursing services to six schools in the County. This service is contracted individually with each school and offers:

- Immunizations
- Vision and Hearing Screening
- Fluoride Mouth Rinse
- Employee health
- Lice screening and follow-up
- Communicable Disease follow-up
- Emergency Nursing
- Human Growth & Development education
- Blood Borne pathogen education and training

Public Health Preparedness & Response

Our Departments Emergency Preparedness Program is funding through grant dollars from Federal pass through funding and the Wisconsin Department of Public Health. This allows our Department to train and prepare for emergency public health disasters. Training includes Incident Command, Epidemiology/disease follow-up, mass clinics and many other skills that pertain to a public health emergency.

Human Services Nursing

Our Department partners with Lafayette County Human Services to provide nursing for the Community Support Program (CSP). This program serves a variety of County residents who may suffer from chronic mental illness, or that require medication

management. Our Public Health Nurses work directly with case managers, psychiatrists, and provide client assessments, education, and skilled nursing assessments.
