## How to Pay Your Taxes Online

- 1. Go to Lafayette County's website: www.lafayettecountywi.org
- 2. Under the "Departments" tab
- 3. Choose "Treasurer"



- 4. Once on the Treasurer page, click the "Property Taxes" menu (it will expand)
- 5. Choose "Paying your Taxes" (the link to pay online is under the "Paying Postponed or Delinquent Taxes" section)
- 6. Click on the <u>HERE</u> link to go to <u>Ascent Land Records</u> (<u>https://ascent.lafayettecountywi.org/AscentLandRecords</u>)



7. Once you are on the Lafayette County Ascent Land Records Suite, search for your tax parcel by Parcel ID or by First Name and Last Name or by Street Number. Remember: Less Is More!
